Executive Summary

CAS-ITE had an active and successful year in 2017. Our Section sustained membership participation by continuing to provide great technical meetings and engaging social activities. We have also increased our engagement with our local Student Chapter through social events, engaging a liaison to directly communicate to the Student Chapter, supporting participation in the Traffic Bowl, and scholarship awards.

Membership

The Capital Area Section currently has the following statistical membership grades as of December 31, 2017:

- 120 International ITE Members
- 35 Student Members
- 8 Fellow Members
- 3 Section Affiliates

This year, upon recommendation from the International Board, the Capital Area Section agreed to participate in a universal dues structure for the Texas District (TexITE). After review of all Section Dues for the Texas District, it was agreed that a flat dues rate of \$15 would apply to all members wishing to be International Members with the exception of students, whose membership remains free. For Section Affiliates, our dues remain unchanged from the previous calendar year. CAS-ITE has the following dues structure:

- Active Professional Members \$15
- Retired Professional Members \$5
- Students, Life & Honorary Members \$0

Section Activities

- Our Section held four (4) Section meetings and one (1) joint meeting with the South Texas Section covering a variety of topics.
- CAS-ITE hosted two (2) Traffic Bowl Scrimmages in support of the UT Student Chapter Traffic Bowl Team. These were held in April and July.
- The Section held a TopGolf Tournament Scholarship Fundraiser, which was made possible by 13 corporate sponsorships, generating \$2,470 in additional revenue and allowing CAS-ITE to distribute \$1,000 in scholarship awards.
- The Section continued the Keep Austin Beautiful Adopt-a-Street program and held two (2) clean-ups with increasing attendance at each one. The Section will continue this activity in 2018.
- Overall, Section meetings and social events had a total of 259 attendees over the course of the year.



Section Committees

- The Section's Communications Committee, led by 2016 President Rob Belarmino, was responsible for the development of our semi-annual newsletter. The newsletter includes articles about Section meetings, including local member and Student Chapter participation at District, and International events. It also features members that are "on the move" and provides insight into some of our area's key local projects.
- The Scholarship Committee, chaired by Cody Stone with Jamie Byers, Derek Mueller, and Jake Gutekunst, revised our scholarship application, collected and reviewed completed scholarship applications, and selected our 2017 scholarship winner.
- The Nominating Committee (Brian Van De Walle and James Kratz) identified candidates, collected candidate information, coordinated with TexITE to setup the online election, and counted the on-site ballots for our annual elections.

Section Student Chapter

- CAS-ITE and the UT Student Chapter hosted two (2) Traffic Bowl Scrimmages at Varsity Pizza to provide support for the students' quest to become International Collegiate Traffic Bowl Champions.
- The majority of the attendees of the Keep Austin Beautiful Adopt-a-Street Cleanup are members of the UT Student Chapter. This event remains a positive way to engage with the students while allow all of us to give back to our local community.

Awards/Honors

CAS-ITE presented service award plaques and certificates to the following members:

- Alex Reyna for providing two (2) years of service as Section Representative
- Valerie Kaiser for providing three (3) years of service on the CAS-ITE Board (2014-2016)
- CAS-ITE awarded \$1,000 in student scholarships in 2017.
 - One (1) \$1,000 Student Scholarship to the CAS-ITE Scholarship Winner: Krishna Gurumurthy

Finance and Budget

- The CAS-ITE balance forward from 2016 to carry into 2017 was \$1,734.63.
- Retained earnings from 2017 into 2018 is \$5873.53.
- 2017 total revenue was \$9,880 including \$2,450 from our corporate sponsors, \$990 in revenue from special meetings, \$1,240 in Section Dues, and nearly \$5,000 in gross revenue from our scholarship fundraiser.
- 2017 total expenses of \$5,740 included support of our UT Student Chapter (including scholarships) in excess of \$2,100 and fundraising costs of \$2,480.



Introduction

The Capital Area Section of the Institute of Transportation Engineers (CAS-ITE) was founded as a chapter of the Texas District of ITE (also known as District 9 of ITE or



TexITE) in 1998, and granted a Section Charter on August 1, 2002. CAS-ITE is one of six (6) Sections within the TexITE representing major urban areas in Texas.

CAS-ITE serves transportation professionals within the Austin area, which includes Travis, Williamson, and Hays Counties. Our members are traffic and transportation engineers, transportation planners, designers, consultants, signal technicians, contractors, vendors, inventors, researchers, professors, students, and policy makers who work to maintain and improve surface transportation systems worldwide.

As a Section we promote the professional development of our members, increase public awareness of our profession, and provide opportunities for the exchange of technical and policy information. Our Section also provides support to our local UT Austin Student Chapter in the form of scholarships, mentoring, preparation for Traffic Bowl competitions, and financial support to attend TexITE and ITE meetings. In addition, we serve as a conduit to provide information regarding the benefits of becoming an ITE member. Affiliation with a Section or Chapter affords individuals an opportunity for local involvement with their peers and to explore the benefits of becoming a member of the Institute and TexITE.

Evaluation of 2017 Goals

Below is a list of the goals identified in last year's Annual Section Report and our evaluation of our performance of those goals.

- Increase public sector participation particularly at the county and city levels.
 - While maintaining MailChimp directory helped, the biggest drivers in attendance is availability, topic presented, and location of the meeting.
- Advance our outreach to the UT-Austin Student Chapter through joint meetings and other events.
 - Jake Gutekunst continued as the CAS Student Liaison in 2017 and is continuing in this role in 2018.
 - We had two activities with the Student Chapter.
 - Two Traffic Bowl Scrimmages on April 13 and July 21, 2017.
- Maintain CAS-ITE scholarship program at \$3,000 in annual distributions.
 - After coordination with the Student Chapter, we restructured the scholarship distributions to a \$1,000 winner at the end of 2017 and at least two (2) winners of a separate scholarship competition in 2018 to offset travel costs to the 2018 Joint Meeting with Western District in Colorado.
- Maintain the Communications Committee and semi-annual newsletter.
 - Continue June/December publication targets.
- File Taxes and Obtain 501(c)3 Status.
 - The Capital Area Section filed taxes in 2017 and received our 501(c)3 status. The Capital Area Section also registered as a not for profit corporation in the State of Texas.
 - Our 501(c)3 tax exempt status allowed us to save money on the scholarship fundraiser and banquet luncheon.
- Identify continuing education opportunities that support the interests of all members.
- Identify and develop future leaders within the organization.
- Create social activities that enhance professional connections among the membership.



 We continued our participation the Keep Austin Beautiful Adopt-a-Street program. Our street segment is 45th Street from Burnet Road to Guadalupe Street in central Austin. We had two cleanups on March 11 October 28, 2017 with increasing professional participation as well has high participation from the UT Student Chapter.

Goals for 2018

Our Section will continue to meet the goals in our charter as well as the following:

- Increase public sector participation particularly at the county and city levels.
 - Continue efforts to improve communications and setting dates that do not conflict with other major events.
- Advance our outreach to the UT-Austin Student Chapter through joint meetings and other events.
 - Have at least one (1) Traffic Bowl Scrimmage before the Joint Meeting with the Western District.
 - Continue to use our Student Liaison to identify activities that the Student Chapter has an interest in attending.
- Maintain CAS-ITE scholarship program at \$3,000 in annual distributions.
- File Taxes and maintain 501(c)3 Status.
 - Engage with TexITE to follow up and provide additional information/support when needed.
- Identify continuing education opportunities that support the interests of all members.
- Identify and develop future leaders within the organization.
- Create social activities that enhance professional connections among the membership.
- Support ITE and TexITE in preparation for the 2019 Annual Conference in Austin.

Membership

The Capital Area Section of the Institute of Transportation Engineers currently provides the following membership grades:

- Section Members Any TexITE (ITE District 9) Member or Affiliate who resides or works within the area designated for the Section, and who is in good standing with TexITE, shall be eligible to become a Section Member and shall become a Section Member upon payment of Section dues. Any member of the Institute of Transportation Engineers (ITE) may become a member of the Section, without residing or working in the Section area, upon approval of the Section members.
- Section Affiliates Any other interested individual who is not a student and who resides or works within the Section boundaries may, at the discretion of the Section, become a Section Affiliate upon payment of Section dues. CAS-ITE had three Section Affiliates in 2017.



Our Section also welcomes both Student Members who are enrolled in a recognized transportation related program at an engineering or planning school and resides within the designated boundaries of the Section.

The Capital Area Section currently has 163 International Members as listed by the ITE website (www.ite.org). Table 1 provides a breakdown of the membership grade of these International Members.




Figure 1 – 2015-2017 Membership Grade Comparison



Section Activities

Section Meetings

The Capital Area Section held regular meetings throughout the year, which included four (4) Section meetings and one (1) joint meeting with the South Texas Section (STITE). The topics covered both technical subjects and policy. As we have done historically, our first meeting was an ethics seminar provided by the Texas Board of Professional Engineers which allows for our members to meet their Professional Development Hour

Our May meeting featured an overview of Capital Metro's **Connections 2025 Strategic Plan** program by **Sam Sargent**. Sam discussed Capital Metro's Strategic Plan which includes both route re-structuring and capital improvements. This was the first presentation from Capital Metro since the 2014 Urban Rail Bond. During this meeting, the CAS board announced two great accomplishments. First, the UT Student Chapter won the Texas District won the Traffic Bowl up in Frisco and would compete in the international competition in Toronto. Second, Alex Reyna announced that Austin was a candidate for the for the 2019 Annual Meeting and Exhibit.



One of our most popular events of the year is our annual Joint Meeting with the South Texas Section of ITE (STITE). This meeting takes place in San Marcos and features a barbecue lunch. This year, we focused on transportation policy and invited Representative Ina Minjarez of District 124 and Mark Jones of Hays County Precinct 2. Representative Minjarez gave an overview of the transportation bills passed by the legislature, including funding allocations for TxDOT. Other bills ranged from legislation to improve safety to better defining coordination between state and local agencies. Commissioner Hays described the challenges associated with a fast growing County and efforts the Commissioner's Court and other agencies are taking to plan for future growth. He highlighted the Interstate 35 corridor as critical for County mobility and praised the active involvement of TxDOT and CAMPO to develop plans to improve the corridor. He also mentioned steps the County has taken with their transportation bond to address safety and congestion concerns on County corridors.

Our August meeting with TxDOT's John Nevares, P.E. provided an overview of ITS in Texas and the Transportation Systems Management and Operations (TSMO) initiative. Mr. Nevares described the ITS programs that TxDOT is implementing to mitigate congestion in Central Texas. He described variable message guide signs (shown to the right) to better inform drivers, over-height detection systems, and improving communications to traffic signal infrastructure. He also discussed upcoming professional services projects for consulting companies.



Our October meeting featured Ashby Johnson of the

Capital Area Metropolitan Planning Organization (CAMPO). Mr. Johnson discussed CAMPO's upcoming projects and studies, such as the MoKan Corridor Study and upcoming meetings with local officials in the CAMPO jurisdiction for changes to the project selection process. He also discussed some the population growth projections in the Austin area, as well as a summary of the projected projects in the Austin area.

Social Activities

In addition to the regular Section Meetings, the Capital Area Section held social events throughout the year. These included outreach efforts to support the UT Student Chapter by participating in a Traffic Bowl Scrimmage, fundraising events such as our TopGolf Tournament, as well as service events. Table 3 shows the summary of the social events held by the Section.

Our first and second social events of the year were held with the University of Texas Student Chapter. The first was a Keep Austin Beautiful (KAB) Adopt-a-Street Cleanup held on March 11 as part of the Section's community service effort. This event was well-attended, with four members from the professionals and eight from the Student Chapter. After the cleanup, the group enjoyed some mud bugs at the Flying Saucer. We held another cleanup Adopt-a-Street Cleanup on October 28th, also well attended by the Student Chapter.

The second event was a Traffic Bowl Scrimmage where our professionals and student members challenged the 2017 Traffic Bowl Team to several rounds of traffic engineering trivia. Moderated by Jake Gutekunst, students and professionals alike enjoyed food, laughs, and the challenging fun that is a game of Traffic Bowl. The first game was won by the ITE professionals. The UT student chapter came back strong and won the second game, however, and appeared poised for victory at the Spring TexITE meeting. The event brought together the local student chapter and the CAS-ITE for a fun and engaging time to connect, and continues as a tradition each spring. The UT student team went on to win

at TexITE, representing the Capital Area Section and UT Austin. A second lunchtime scrimmage was held on July 21 in anticipation of the UT Traffic Bowl Team's competition in Toronto at the Annual Meeting. This scrimmage had even better professional participation than any of the previous scrimmages in recent memory – which will guide our 2018 scheduling of the event. Unfortunately, the team was unable to bring the trophy back to Austin, however, the Capital Area Section remains ready to help the team in 2018.

The Capital Area Section resumed its Scholarship program in 2012 and started to host a major fundraising event in 2014 to support the scholarship. Previous scholarship events were a Skeet Shoot (2014), Bowling Tournament (2015) and TopGolf (2016). Based on the popularity and success at the 2016 fundraiser at TopGolf, the section held the fundraiser at TopGolf in 2017. We offered multiple levels of sponsorship so companies could create teams – and most did. The event provided three (3) hours of golf with brunch



and the opportunity to compete for individual prizes. **Austin Helton, Eric Poppa**, and **Scott Feldman** received the top scores and took home the 1st, 2nd, and 3rd place prizes, respectively. Prizes included a gift card and Kindle Fires. Over 30 golfers showed up on a rainy November morning and raised over \$2,400 for the scholarship.

Our final event was the Year-End Banquet held at Threadgills on North Lamar on December 1, 2017. The Capital Area Section enjoyed some of Austin's local cuisine while electing our incoming officers and honoring our past board members. More details on this event are outlined in the *Section Committees* and *Awards* sections of this report.

Section Committees

Capital Area Section Communications Committee

The Capital Area Section Communications Committee, chaired by Rob Belarmino, was responsible for the return of our Section newsletter back in 2015. He continued this into 2017 and released our newsletter in June 2017. The newsletter summarizes our past and upcoming meetings and social events, and provides a services directory featuring our sponsors. Refer to Appendix A for copies of the newsletter for 2017.

In addition to our newsletter, the website (<u>http://texitecapitalarea.weebly.com/</u>) is one of our primary ways of reaching out to existing and potential members; it is regularly updated by the Secretary-Treasurer with the latest Section information including officers, membership forms, Section meeting attendance records for PDHs, and upcoming meetings/events.

The Communications Committee has continued its regular use of the MailChimp email marketing service provider, managed by the Secretary-Treasurer, to send out Section information and notices of upcoming meetings and events.

Capital Area Section Scholarship Committee

The 2017 Capital Area Section Scholarship Committee was chaired by Cody Stone and Derek Mueller. The Scholarship Application was announced via e-blast and posted to the website. Jake Gutekunst worked closely with the UT Student Chapter to advertise the scholarship, which was due in early November.

With the support of the Fundraising Committee's TopGolf Tournament Scholarship Fundraiser, which received the strong support of our corporate sponsors with 13 firms acting as sponsors of this event, the Section will be able to award \$3,500 in scholarship funds. The Scholarship Committee received six (6) applications and awarded a \$1000 scholarship to the winner. It was determined that remaining scholarship funds would be redirected in 2018 to a new scholarship that will provide support for student attendance of the Joint District Meeting in Keystone, Colorado. Details about the Scholarship Award winners are in the Awards section of this report.

Capital Area Section Nominations/Elections Committee

The 2017 Capital Area Section Nominations/Elections Committee was chaired by James Kratz and Brian VanDeWalle. The CAS-ITE Executive Board elections are held in



December of each year with the results announced at the Annual Year-End Banquet. The Section Officers began solicitation for the 2017 Section Officer Election at the August meeting and via e-blasts to our members for the positions of Secretary-Treasurer and Section Representative. Cody Stone and James Schwerdtfeger ran unopposed for Secretary-Treasurer and Vice President, respectively. The Election Committee received the two nominations for the Section Representative position, Alex Reyna and Sam Higgins.



The Nominations/Elections Committee administered the election online with the assistance of Gary Thomas, TexITE Webmaster, and collected paper ballots during the Year-End Banquet on December 1st. James Kratz tallied the results and announced that Alex Reyna was re-elected Section Representative. James Kratz then administered the oath of office for the 2018 Officers and Members.

The second section meeting held on May 12 at the Waller Creek Center with a presentation from Capital Metro's Community Involvement Coordinator, **Sam Sargent, JD**. The meeting highlighted Capital Metro's Strategic Plan, including an update on Capital Projects. The meeting was attended by about 29 affiliate and non-affiliate CAS-ITE members.

President Valerie Kaiser, opened the meeting with a roll-call and section business. Valerie along with **Vice President Tom Gerrity** and **Secretary-Treasurer James Scwerdtfeger** informed the attendees that the UT Student Chapter had won the TexITE Traffic Bowl. The board members congratulated the students on the win and wished them luck at the **2017 ITE Annual Meeting and Exhibit in Toronto, Canada**. In preparation for the International Traffic Bowl, the CAS-ITE will host another Traffic Bowl Scrimmage in July prior to the international games.

Valerie also provided an update on the current CAS-ITE filing as a non-profit organization. She informed everyone that CAS-ITE's previous EIN cannot be reactivated as it has expired and that we would have to re-register as a new Texas non-profit with a new EIN. The IRS will be refund the filing fee back to CAS-ITE. Valerie and Tom also reminded everyone about the upcoming Joint Meeting with South Texas Section and upcoming increase to the annual business card ad sponsorship fee from \$100 to \$150 by June 2017.

Following the section business, Valerie introduced Sam and provided an overview of his background and presentation. Sam started his presentation by outlining Capital Metro's history, organization, service area, and system. Capital Metro currently provides transportation services through a fleet of bus, rail, shuttle and ride share services. The system currently has 14.75 million revenue miles and experiences 105 thousand daily ridership, and 32 million annual ridership.

Capital Metro currently offers three types of bus services on its system, which include: MetroBus, MetroRapid, and MetroExpress. MetroBus provides local services and UT shuttle routes, this service is expected to receive major changes as part of Connections 2025 program. MetroRapid is the bus rapid transit system and currently operates in two routes (801, and 803), which has experienced a 20% increase in ridership as of March 2017. MetroExpress provides commuter services through seven routes, which will increase to eight routes with the addition a new Howard Route using the MoPac Managed Lanes.


Capital Metro's also offers both passenger and freight rail services. The passenger rail services are offered through the Red Line which extends from Leander to downtown Austin. The freight line operates between Giddings and Llano.

The Red Line began operations in 2010 and currently has nine metro rail stations, and had over 814 thousand in ridership in 2016. The continued ridership growth of the Red Line has prompted Cap Metro to re-evaluate service and improve commuter experience. Capital Metro will use a TxDOT \$50 million grant to add four additional rail cars to their fleet, and develop a new Downtown Rail Station. The Downtown Rail Station project will construct two new tracks to capacity and create a new public plaza near the Austin Convention Center along 4th Street. The downtown project is currently in the 60% design phase. Moreover, Capital Metro also has a TIGER V Railroad Infrastructure Improvement Program aimed at improving rail infrastructure. This program was developed through a \$35 million FTA grant to provide improvements to track sections, bridges, vehicle improvements and develop new passing tracks. Some of the project locations include infrastructure improvements at the Austin Junction (East 6th Street and Pedernales), Lakeline Station, Crestview Station, and Brushy Creek Trail.

With the increase in rail cars, Capital Metro is also improving their North Operations Rail Maintenance Facility. The project will increase fueling capacity, expand maintenance building, improve safety, and add a track section. This project is scheduled to complete by 2018. Furthermore, Capital Metro will plan to develop a new Leander North Maintenance Facility to further improve operations.

Sam also discussed several park and ride improvements that are being developed. With several facilities at near, or over, occupancy Capital Metro plan to increase parking accommodations at Lakeline, Howard, and South Congress Transit Center. Capital Metro will also develop a new Westgate Park & Ride Facility that will be located between Pack Saddle Pass and Manchaca Road at Ben White Boulevard.

Finally, Sam outlined several of the bus route improvements that are taking place. Some of them include addition of MetroRapid stations for both Route 801 and 803, accessibility and amenity improvements such as shelters for select locations, signing/technology improvements, and connectivity improvements.

June 30 Annual CAS-ITE and STITE Joint Meeting

The Capital Area Section joined the South Texas Section for our annual Joint Meeting in August. The meeting has become a tradition where both sections meet to learn about topics relevant to transportation in both areas. 21 Capital Area members and 15 South Texas Members enjoyed a BBQ lunch at the San Marcos Activity Center. The first speaker was Representative Ina Minjarez from Texas House District 124. As a member of the Transportation Committee, she was able to provide insightful information on transportation legislation from this year's session. Representative Minjarez gave an overview of the transportation bills passed by the legislature, including funding allocations for TxDOT. Other bills ranged from legislation to improve safety to better defining coordination between state and local agencies.

The second speaker was Hays County Precinct 2 Commissioner Mark Jones. As one the fastest growing counties in the nation, Hays County is experiencing rapid increase in congestion. Commissioner Hays described the challenges associated with a fast growing County and efforts the Commissioner's Court and other agencies are taking to plan for future growth. He highlighted Interstate 35 as a key concern for County mobility and praised the active involvement of

TxDOT and CAMPO in helping to develop plans to improve the corridor. He also mentioned steps the County has taken with their transportation bond to address safety and congestion concerns on County corridors.

In September, many members will return to San Marcos for the TexITE District Meeting.


