Webinars

The Section has funded and hosted 11 different ITE webinars in 2010 with an attendance varying from 10 to 22 section members. The webinars included are the Fundamentals of Traffic Engineering Web Series (8 modules), Ask the Access Board - Accessible Pedestrian Signals, Retrofitting for Complete Streets, and Roundabout Design and Operations.

Student Scholarships

The Section awarded Year 2009-2010 TexITE scholarships to three local transportation students enrolled in an undergraduate or post-graduate academic program. Ahon Guo, Elizabeth Heeb, and Aaron Respass were each awarded \$500 scholarships and certificates for their academic achievements. The Section decided to increase the amount for future TexITE scholarships to a total of \$3,000 (with the single recipient maximum at \$2,000). Applications for the Year 2010-2011 scholarships are being accepted and will be reviewed by the Scholarship Committee for award in April 2011.

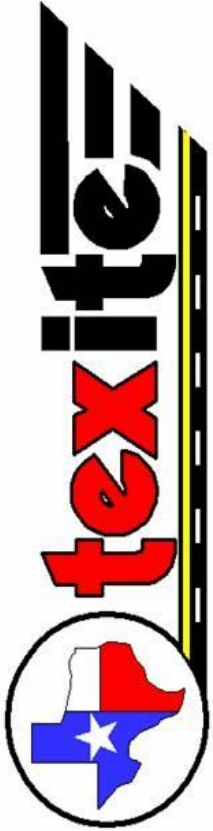

2010 Summer TexITE Meeting

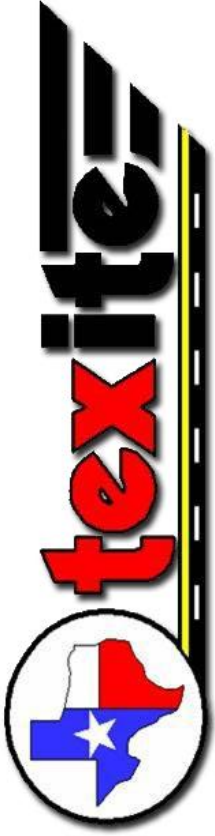
The Section hosted the 2010 Summer TexITE conference on June 17-19 in Sugar Land, Texas. The conference was held at the Sugar Land Marriott Hotel, and about 313 persons registered for the conference. Full registration included 168 ITE and two retired members, 29 students, 10 speakers and 23 vendors or non-members. Part-time registration included 81 persons and vendors. The meeting was well organized and had good attendance. The Local Advisory Committee included two coordinators and 19 local members serving on ten subcommittees.



The Section, in coordination with TexITE District staff, was able to provide the Alternative Intersections and Interchanges Workshop that was presented by Dr. Joe Bared from the Federal Highways Administration. 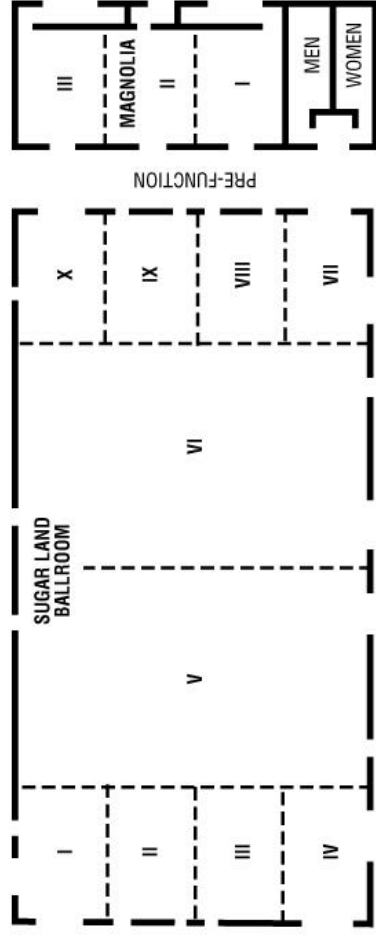

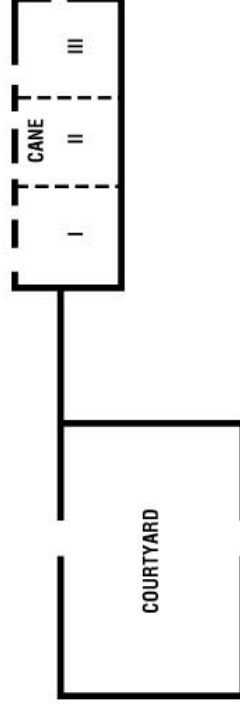

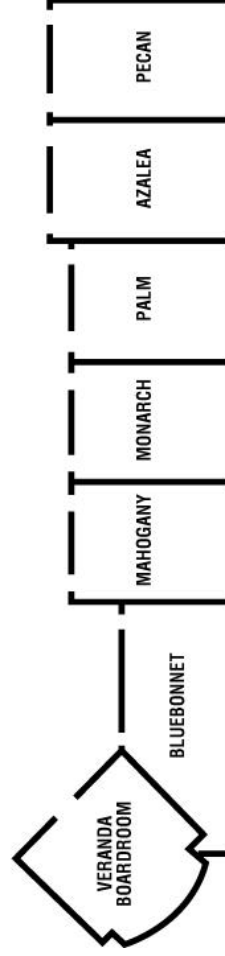
MEETING MAP
