SECTION HISTORY

The South Texas ITE Section (STITE) is a sub-area of District 9 of the Texas District of ITE (a.k.a. TexITE). The section was formed in 1997 and includes 46 counties in the area that stretches from Del Rio to San Antonio to Victoria and south to the Rio Grande Valley (more land than some states!). STITE boundaries include McAllen, Laredo, Corpus Christi, South Padre Island, Kingsville, Harlingen and Brownsville. There have been few opportunities in South Texas for people in the transportation industry to network with their peers, enhance technical skills or learn new methods of controlling and planning for traffic.


OTHER

Troy D. Walden, Ph.D. Associate Research Scientist Texas Transportation Institute "Evaluation of Photographic Traffic Signal Enforcement Systems in Texas"

Mr. Walden is the author of the recent study entitled "Evaluation of Photographic Traffic Signal Enforcement Systems in Texas". This study, which was conducted within the Center for Transportation Safety of the Texas Transportation Institute, examined more than 11,000 crash records at 275 Texas intersections where cameras were in place. It compared crash frequencies in each of the three years before and after the installation of the red light safety cameras. The study is one of the most extensive thus far in the nation.




Ismael C. Soto, P.E. Director of Traffic Operations TxDOT - Corpus Christi District "Potential Impacts of the 2011 Texas MUTCD"

Mr. Soto graduated from Texas A&I University in Kingsville and has 15 years of traffic engineering experience with TxDOT (1 year with Cal-Trans). He helped develop the traffic simulation model for the busiest freeway in Corpus Christi that led to the project that eliminated morning stop and go traffic that had plagued the freeway for 30+ years. Mr. Soto will be discussing potential impacts of the 2011 TxMUTCD on the engineering community.

HNTB Corporation "Recovering from Disaster – Texas' Approach to Recovering from Hurricanes Dolly and Ike"

In 2008 hurricanes Dolly and Ike came ashore and created an estimated \$29 billion in damage to infrastructure within the State of Texas. In 2010, HNTB was awarded a \$69.5 million contract that includes tracking the progress of 3,000+ projects that will rebuild water/wastewater facilities, roads, bridges and some public buildings in the 63-county affected area. Key Project Managers from HNTB will be updating attendees on the progress of the project and what has been accomplished thus far.

Mike Garza and Secretary/ Treasurer Amy Lewis gave the treasurer's report stating STITE had over seven thousand dollars in its account at the end of 2010. Mike Garza then introduced the featured speaker, Mike Frisbie, City Engineer.

Mr. Frisbie started his presentation by detailing upon a successful vote. his previous work experiences in Wyoming, Utah, and Arizona. He shared experiences and insights he learned at these positions.

He then gave a summary of the City's 2007 Bond Program. 76 percent of the projects on the bond are currently completed or in construction. The \$550 million bond consisted of 150 projects throughout the city. Mr. Frisbie talked about successful elements of the bond program as well as areas which could be improved.

Mr. Frisbie then gave an update on the status of the 2012 bond program. The bond is expected to be approximately \$600 million. The City is currently selecting projects to be put in the bond program through community bond committees. The bond program will be voted upon in the May, 2012 election. The projects are scheduled to begin immediately

Mr. Frisbie said the City was hoping to improve aspects of the bond program from 2007 such as avoiding peaks and valleys in the work load, creating project schedules earlier, and updating the Design Guidance Manual.





US 281 & Lp 1604 Interchange Design/ Build



The June 2011 lunch meeting was held June 29, 2011 at the Club at Sonterra.

President **Rob Belarmino** opened the meeting and encouraged everyone to attend the upcoming ADA workshop and TexITE meeting in Garland. Vice President **Mike Garza** gave an update on Section news and Secretary/Treasurer **Amy Lewis** presented the current account balance for the Section. Rob then introduced the first speaker, **Brett Altman** of Jacobs Engineering.

Mr. Altman gave an overview of the US 281 and Loop 1604 interchange project, which is currently under construction. The interchange is managed by the Alamo RMA and is a design/ build project with William Brothers Construction and Jacobs Engineering. Mr. Altman gave details about the project and shared some of his experiences working on the project. The total cost of the project is \$190 million and will construct the four direct connectors south of Loop 1604. The project is expected to be completed in the summer of 2013.

The next speaker, James Kratz of Jacobs Engineering spoke in more detail about the

traffic engineering aspects of the project. One aspect of the design is the left exit on northbound US 281 for the direct connects to Loop 1604. Mr. Kratz discussed the analysis and design of this exit to minimize operational problems. He also discussed how the design process for design/build projects differed from conventional projects. Because the construction contractor had input in all stages of the design process, they were able to be more actively involved in the traffic control plan design. This allowed them to develop a more efficient construction sequence.

Angel Gonzales of GKW then gave further insight into the traffic engineering and analysis for the project. He showed animations from the VISSIM traffic simulation model of the proposed interchange. The modeling of the left exit was used to determine the placement of the advanced warning signs for the exit. In addition to the direct connects, Mr. Gonzalez also said pedestrian bridges would be constructed across US 281 on both sides of Loop 1604 to provide better pedestrian access to the businesses on either side of US 281.

What's New at Trafficware



The July STITE lunch meeting was held July 27 at the Club at Sonterra. STITE President **Rob Belarmino,** Vice President **Mike Garza**, and Secretary/Treasurer **Amy Lewis** opened the meeting with section news. Rob Belarmino then introduced the first speaker, Michael Trueblood, Senior Traffic Engineer at Trafficware.

Mr. Trueblood discussed new software and programs offered by Trafficware. He first discussed *Synchro 8*, the newest version of the Synchro Traffic analysis software. Mr. Trueblood discussed how *Synchro 8* incorporates the *Highway Capacity 2010* methodologies into it's analysis. This includes the ability to analyze multi-lane roundabouts as well as multi-modal analysis at signalized intersections to analyze the operation of bicycles and pedestrians.

Additionally, Mr. Trueblood gave an overview of other aspects of the new version such as an updated user interface and the ability to record video files of the *SimTraffic* simulations. Additional simulation parameters were also added to aid in the modeling of certain features such as ramp meters or rail crossings. The new version also incorporates a more streamlined method of importing aerial backgrounds into the model.

Mr. Trueblood also discussed Trafficware University, which is a collection of traffic engineering courses and technical papers offered by Trafficware. Trafficware University offers a wide variety of topics, ranging from general overviews of traffic engineering concepts to instruction courses on Trafficware software such as *Synchro*.

Mr. Trueblood gave an overview of SynchroGreen, which is a new adaptive traffic signal control package. The adaptive control uses real-time traffic data to adjust the traffic signals in real-time. Mr. Trueblood said one advantage of SynchroGreen is that it has the ability to be modeled in Trafficware's microscopic simulation software *SimTraffic*, so its operation can be analyzed prior to implementation of the system in the field.

The ADA and Public Rights-of-Way Workshop was held August 12 at Morgan's Wonderland. The workshop was jointly held by STITE and WTS - San Antonio Region. The workshop featured sessions by **Janet Barlow** and **Scott Lewendon**.

Janet Barlow, a Certified Orientation and Mobility Specialist, discussed accessible design for the blind. Ms. Barlow specializes in the needs of the visually impaired and has served as a representative on the US Access Board Public Rights-of-Way Advisory Committee from 1999-2007.

Ms. Barlow gave an overview of types of visual impairments and various techniques used by people with visual impairments such as guide dogs and canes. She also described cues visually impaired pedestrians use such as changes in surface texture and the sounds of traffic. Ms. Barlow stressed the importance of clearly defined walkways to provide a path that is easy to follow.

A variety of tasks are involved in safely crossing a street. Visually impaired pedestrians must identify the edge of the street, determine the direction and alignment to cross, and decide when to begin crossing the street. To assist with this, it is important to provide a tactile warning at the street edge and design the pedestrian ramps to properly align the pedestrians to crosswalk.

Ms. Barlow also discussed the location of pedestrian pushbuttons and the importance of Accessible Pedestrian Signals (APS) for the visually impaired. For midblock locations, pedestrian beacons such as the HAWK can be used to provide protected crossings for pedestrians

Ms. Barlow described the proper treatments for pedestrian crossings at roundabouts to provide a more clear path for the visually impaired.

Scott Lewendon is a FHWA Certified Instructor for designing Pedestrian Facilities for Accessibility. He was also a Contributor to the US Access 1999 Design Guide for Accessible Rights-of-Way. Mr. Lewendon discussed pedestrian design and legal requirements for complying with the ADA.

Mr. Lewendon discussed some of the requirements of the ADA, such as transition plans, which are required of public agencies to specify the steps for fixing inaccessible facilities. He also touched on the design guidance manuals for design in public rights-of-way such as the PROWAG, ADAAG, and MUTCD.

Mr. Lewendon then discussed the design of pedestrian facilities. He broke down the various aspects of pedestrian facilities within the right-of-way such as furniture zone, pedestrian zone, frontage zone, driveways, curb ramps, and crosswalks and described the aspects which can affect disabled pedestrians such as steep grades or pavement texture. At intersections, he described crosswalk placement and how it is affected by intersection design elements such radius, median islands as curb and channelized right turn lanes.

Mike Garza and America Garza with Conference Speakers

The Second Annual Regional Conference was held in Corpus Christi, TX at the TxDOT District Office on September 30, 2011. After lunch, STITE President **Mike Garza** welcomed everyone and introduced the speakers.

The first speak, **Troy Walden**, **Ph.D**, from the Texas Transportation Institute (TTI) gave a presentation on the effectiveness of red light cameras. Dr. Walden said that of the 3,600 traffic fatalities in Texas last year, one half were intersection related. Based on a study Dr. Walden performed at 275 signalized intersections before and after red light cameras were installed, the crash rate at intersections with red light cameras was reduced by 11 percent and the number of red light-running related crashes was reduced by 23 percent. Based on this study, Dr. Walden said the red light cameras are shown to significantly reduce crashes at signalized intersections.

The next speaker, **Ismael Soto**, Director of Traffic Operations for the TxDOT Corpus Christi District, gave a presentation on the changes to the 2011 Texas Manual on Uniform Traffic Control Devices (TMUTCD). Mr. Soto's informative presentation covered a wide variety of changes and additions to the TMUTCD. He showed a variety of new signs, pavement markings, and signals, such as the flashing yellow arrow which were included in the latest version.

After Mr. Soto's presentation, presentation, **Peter Harrison** of HNTB gave a presentation on the Disaster Recovery Program, of which HNTB is the program manager. The Disaster Recovery Program is designed to help rebuild after the damage from Hurricanes Ike and Dolly. These two hurricanes affected over 45 percent of the Texas population

and cost more than an estimated \$29 billion in damages. The Disaster Recovery Program is the largest public works program in Texas history and involves more than 5,000 projects.


Next, **Gary Schatz**, Traffic Engineer for the City of Austin, gave a presentation on new initiatives in Austin. Mr. Schatz talked about Austin's Great Streets plan, which aims to increase mobility in the downtown area for all users such as bikes and pedestrians. He showed the modifications they had implemented on South Congress including the addition of bike lanes and reverse angle parking. Mr. Schatz also gave an overview of the HAWK pedestrian beacons which are being implemented in Austin at locations with heavy pedestrian traffic. The Hawk stops traffic with a flashing red signal when pedestrians are crossing and is unlit at other times. He also discussed roundabouts and gave examples of when their installation may be appropriate.

A vendor session followed Mr. Schatz' presentation. Following the vendor session, George P. Hartman of the Texas Board of Professional Engineers gave an ethics presentation. Mr. Hartmann gave updates on new rules and legislation as well as case files of ethics violations.

Following the conference, attendees had dinner at Snoopy's on the pier. The fishing tournament was held the next day. Photos and awards from this tournament can be seen on the next page. The STITE board would like to thank all of the vendors for helping to sponsor the event and America Garza and the TxDOT Corpus Christi District for hosting and organizing the conference.


