#### 4.2 Committees

The **Younger Members Committee** was chaired by Tom Hartmann (Kimley-Horn and Associates). The Younger Members Committee was responsible for publicizing the Greater Dallas Section Scholarship and helping host the scholarship golf tournament.

The **Scholarship Golf Tournament Committee** was initially chaired by Cameron Williams (Walter P Moore), and then later transferred to Hiron Fernandez (Kimley-Horn) in the Fall of 2013. The Committee planned a successful scholarship golf tournament held on May 10, 2013 to raise money for transportation engineering scholarships.

The **Scholarship Selection Committee** reviewed applications and made a recommendation of the students most worthy of receiving a Greater Dallas Section Scholarship. This Committee was chaired by John Black (City of Richardson) with the Section President and Younger Members Committee Chair serving as the other members.

The **Professional Development Committee** organized several webinars for members to attend. Our professional development activities are highlighted in more detail later. This committee was made up of Wes McClure (TxDOT), Chair and Jeremy Wyndham (Jacobs).

The Nominating Committee nominated candidates to run in the 2013 election for Section Secretary-Treasurer and Vice-President, and also for the Section Representative to the Texas District 9. The nominating committee was chaired this year by Susan Langdon (Savant Group) with Kelly Parma (Lee Engineering) and Tom Simerly (DeShazo Group) serving as members.

The **Tellers Committee** confirmed the online vote tabulation and declared a winner of the 2013 election. This committee was made up of Susan Langdon and Kelly Parma.



# 4.3 Professional Development Activity

The Greater Dallas Section Professional Development Committee has a goal of providing at least one training session per quarter. The Committee works to find local firms and agencies to sponsor and host an event. They are also expanding the scope of their efforts to include identifying professional development opportunities available in the Region (outside of ITE) and sharing these with our membership. The third annual tournament involved 76 golfers, with 21 sponsor companies participating at various funding levels at our event. ### 4.5 Greater Dallas Section Scholarship Award

Due to the success of the Golf Tournament, we awarded \$5,000 in scholarships to the following students in July 2013:

- Hossein Hashemi, Southern Methodist University, \$2,000
- Sunil Madanu, University of Texas at Arlington, \$1,700
- Shawn Poe, University of Colorado Boulder, \$1,300

Each of these students was awarded the scholarship based on their application and demonstration of financial hardship while pursuing a degree in civil engineering.

# **5.0 Other Business**

# **5.1 Officer Elections and Appointments**

Jessica Shutt notified Robyn Root on July 29, 2013 that she was resigning as an officer. Therefore, on August 2, 2013 the Executive Board appointed Cameron Williams (Walter P Moore) to fulfill the remainder of the 2013 term of Secretary/Treasurer.

For the 2014 term, the nominating committee selected candidates for the offices of Secretary/Treasurer, Vice-President, and Section Representative. Cameron Williams (Walter P Moore) and Rob Kouba (HNTB) were selected by the Nominating Committee to run for the Secretary-Treasurer position. Yang Ouyang (NTTA) and Gary Graham (City of McKinney) were the nominated candidates for Vice President. Robert Saylor (City of Richardson) and John Denholm (Lee Engineering) were the two candidates for Section Representative to the Texas District. Online voting was available between October 15 and November 30. The results were presented at the December 13, 2013 Section Annual Business Meeting and the new officers were sworn in for their 2014 terms. Cameron Williams was elected to the position of Secretary-Treasurer, Gary Graham was elected to serve as Vice-President, and John Denholm was elected as the Section Representative.

# 5.2 Changes to Section Bylaws

# 5.3 Resolutions Passed by the Section

One new Resolution was introduced and passed during the meeting on August 9, 2013. This resolution allows the Dallas Section to provide up to \$1,000 to any individual member(s) of this Section in financial support if they are selected for the ITE Leadership program. The inaugural class selected in the Fall of 2013 did include one member from the Dallas Section (Jody Short – Lee Engineering). The contribution to Jody will be made in early 2014.
