6.3. Changes to Section Bylaws

On July 7, 2014, a majority of the BVITE membership voted to modify the Section Bylaws which removed the elected position of Secretary-Treasurer and created a Section Administrator to cover these duties. This position is appointed by the BVITE President and has a one-year term with no limit on consecutive terms. The modification of the BVITE Section By-Laws were approved by vote of the District Board on September 24, 2014.
